Prep for Re-Affirmation With Confidence

The Higher Learning Commission's updated Criteria for Accreditation, transition to the Canopy platform, and overhauled Institutional Update requirements are converging in 2025. This checklist helps ensure your institution is prepared strategically, operationally, and culturally.
